1 Briefly describe the organization's mission

Boys Republic provides both residential and non-residential youth services to disadvantaged, at-risk young people from throughout California. It operates six facilities, all in Southern California: a 200-acre residential campus, school, and farm in Chino Hills; three residential group homes for boys in Los Angeles, Pomona and Santa Ana; a Girls Republic group home in Monrovia; and a non-residential day treatment center and school in the city of Monrovia. Total capacity for all facilities is 208 which includes 168 residential beds and 40 day treatment positions. Boys Republic provides a diverse program of educational, psychological, vocational and family reunification services.

Residential Treatment - providing residential services to disadvantaged, at-risk young people from throughout California. During the year covered, the program provided 44,953 days of care to 745 clients.

Nutrition Program - Boys Republic's nutrition program is part of the National school Lunch Program and School Breakfast Program which provides nutritionally balanced, free breakfast and lunch each school day to children in residential placement. During the fiscal year ended June 30, 2016, 67,264 meals were served to 690 individuals.

Family Preservation - The goal of the Family Preservation program is re-integrating youth successfully back into their home and community. In addition to full time schooling, parenting classes, vocational and employment counseling and transportation, the program provides individual counseling to each student on at least a weekly basis, family counseling to each student's family on at least a monthly basis, and group counseling for all students on a daily basis. During the fiscal year ended June 30, 2016, 3,659 days of service was provided for 30 clients.
