The approved compensation plan for the head of school is documented in an employment agreement which is approved by the Board of Trustees. The compensation committee last reviewed this compensation plan in May 2016. Compensation for other officers and key employees is set by the Head of School with input from the compensation committee of the Board of Trustees. The Head of School considers compensation reports and other information from national, regional, and local compensation surveys for comparable positions when determining compensation for other officers and key employees. The Head of School reviews this information with the compensation committee before finalizing the compensation for other officers and key employees. The compensation plans for all officers and key employees are documented in an employment agreement. The compensation committee last reviewed these compensation arrangements in February 2016.
