Phi Kappa Phi Forum is the Society's publication, reaching more than 100,000 active members, government officials, librarians, executives and others. Members also receive a monthly electronic communication, Phi Kappa Phi Focus. A merchandise catalog is included in new member packets and renewal statements to enhance brand awareness. PhiKappaPhi.org keeps members informed of benefits, including grants and awards and discounts and services from corporate partners. The Society manages a variety of social media channels as well to engage members and promote networking. A private online community and corresponding app help members and officers share ideas, discuss challenges, post questions and connect with one another based on specific academic and professional interests.

4b (Code) (Expenses \$ 666,534 including grants of \$ 16,100) (Revenue \$)
Phi Kappa Phi's 315 chapters are encouraged to sponsor campus and community events that recognize and promote academic excellence and engage the community of scholars in service to others. Partnering for Success Workshops and other training sessions are conducted by the staff to strengthen chapters and promote the organization's mission. The Student Leadership Summit is an event that the Phi Kappa Phi national organization holds every other year. It is a two-day leadership experience in which student vice presidents from across the country work with leadership facilitators, the chapter development staff, and each other to develop leadership strategies and outreach opportunities for their chapters. The Society's commitment to excellence is reflected in its award and incentive programs for chapters. Funds are allocated each year for chapter awards and incentives. Chapters are recognized by the national organization with monetary awards for meeting specific benchmarks.

Each new member (27,629) receives a pin and a certificate to distinguish individuals with outstanding scholarship. Brochures and related materials are sent to chapters and members to keep them informed about the organization.
