Arrowhead United Way utilizes a volunteer-driven process to invest resources in initiatives and programs which make a difference in hundreds of ways and thousands of lives throughout our service area By taking the Community's expertise and resources, we efficiently and effectively reach people in immediate need and solve problems for the long term Funded 12 partner agencies (13 programs) resulting in assisting 33,103 individuals Donors designated funds to 304 other non-profit agencies In addition, our initiative program funding served approximately 1,017 people The initiative's included Teens Make a Difference, 931 students participated "Knowledge Revealed" college prep served 86 students Our holiday donations of food and gifts served 527 individuals and our "Santa Train Ride" served 250 children SB United Relief Fund, on December 2, 2015 our community was hit hard by a mass shooting that took the lives of fourteen residents and injured twenty-two others The San Bernardino United Relief Fund was established to raise funds to assist those affected by the December 2nd tragedy A committee of fifteen community members was assembled to decide how the funds were to be allocated The committee reviewed best practices of other communities that had experienced mass shootings Arrowhead United Way is not deducting any administrative fees from donations collected One hundred percent of the contributions are going directly to (1) families that have experienced loss, (2) those that were shot or injured, and (3) those in the room where the shooting took place Digital Marketing Outreach includes 24,037 website visitors 2,271 e-mail followers, 142,294 Facebook visitors and 11,608 Twitter impressions Our Women's Leadership Council program is committed to combining knowledge and resources in order to assist underserved young women by providing the tools to obtain employment through workshops that combine practical topics such as resume writing, healthy lifestyles, self-marketing, appropriate dress etiquette, social networking, job etiquette, and college prep courses The Next Steps Mentoring Program mentors support at-risk young women as they complete high school and/or prepare for post-secondary education or careers for improved quality of life These programs reached 498 young women In-kind collection of food, clothing, medical and school supplies redistributed to organizations and families in need Distributed food valued at over \$267,234, Medical supplies \$383,626, School supplies \$99,674 and holiday items valued at over \$19,550
