PLANNED PARENTHOOD SERVES WOMEN, MEN AND TEENS AND MORE THAN 75% OF OUR PATIENTS LIVE AT OR BELOW FEDERAL POVERTY LEVEL. OUR CALL CENTERS RECEIVE 3,000 CALLS ON THE BUSIEST OF DAYS AND PROVIDE EDUCATION AND INFORMATION TO PATIENTS AND COMMUNITY MEMBERS.
