EDUCATION-ORANGEWOOD FOUNDATION PROGRAMS HELP CURRENT AND FORMER FOSTER YOUTH DEVELOP AND ACHIEVE THEIR EDUCATIONAL GOALS, FROM HIGH SCHOOL TO COLLEGE TO GRADUATE SCHOOL. ORANGEWOOD FOUNDATION HELPS FOSTER AND COMMUNITY YOUTH DEVELOP AND ACHIEVE THEIR EDUCATIONAL GOALS. OUR PROGRAMS INCLUDE OUR SAMUELI ACADEMY CHARTER HIGH SCHOOL, SCHOLARSHIPS FOR COLLEGE AND GRADUATE SCHOOL AND EDUCATION-RELATED WORKSHOPS. DURING THE LAST YEAR, WE ADDED A NEW CLASS OF NINTH GRADERS TO SAMUELI ACADEMY, BRINGING THE TOTAL STUDENT OF FRESHMEN AND SOPHOMORES TO 262 STUDENTS. (NEW CLASS OF FRESHMEN WILL BE ADDED EACH YEAR UNTILL FALL 2016 WHEN THE SCHOOL WILL HAVE GRADES 9-12) SAW TREMENDOUS SUCCESS IN SAMUELI ACADEMY STUDENT ENGAGEMENT AND ACADEMIC SUCCESS. A 97% DAILY AVERAGE ATTENDANCE RATE, 51% OF STUDENTS MADE THE HONOR ROLL, AND A CALIFORNIA HIGH SCHOOL EXIT EXAM (CAHSEE) PASS RATE AMONG SOPHOMORES OF 99% IN MATH AND 94% IN ENGLISH PROVIDED \$762,000 IN COLLEGE SCHOLARSHIPS TO 289 STUDENTS. 36 OF OUR COLLEGE STUDENTS GRADUATED AWARDED \$104,000 IN ADVANCED STUDIES SCHOLARSHIPS TO 15 FORMER FOSTER YOUTH PURSUING ADVANCED DEGREES. SIX GRADUATED OR COMPLETED THEIR PROGRAMS. HELD 14 EDUCATION-RELATED WORKSHOPS ON TOPICS SUCH AS TIME MANAGEMENT, STUDY SKILLS, VOCATIONAL TRAINING OPTIONS, AND GOAL SETTING AND PRIORITIZING, PROVIDING 1,083 HOURS OF INSTURCTION TO 211 YOUTH.

LIFE SKILLS SEVERAL ORANGEWOOD PROGRAMS HELP CURRENT AND FORMER FOSTER YOUTH LEARN ESSENTIAL LIFE SKILLS THAT CHILDREN AND TEENS FROM STABLE FAMILIES OFTEN LEARN FROM THEIR PARENTS, EITHER DIRECTLY OR THROUGH OBSERVATION. OUR PROGRAMS ALSO HELP YOUTH FIND EMPLOYMENT AND DEVELOP JOB-READINESS SKILLS. DURING THE LAST YEAR, WE LIFE SKILLS HELD 33 WORKSHOPS IN THE AREAS OF RELATIONSHIPS AND DAILY LIVING. 2,691 HOURS OF INSTRUCTION WERE PROVIDED TO 288 YOUTH. WORKSHOP TOPICS INCLUDED MONEY MANAGEMENT, HEALTH AND NUTRITION, HEALTHY RELATIONSHIPS, AND EFFECTIVE COMMUNICATION. HAD 23 ORANGEWOOD PEER MENTORS FACILITATE SMALL GROUP BREAKOUT SESSIONS DURING THE WORKSHOPS. PEER MENTORS SERVE AS POWERFUL ROLE MODELS TO OUR YOUTH. HELD SPECIAL EVENTS FOR OUR YOUTH THAT PROVIDED PROM ATTIRE AND BUSINESS SUITS ALONG WITH SELF-ESTEEM WORKSHOPS TO 50 YOUNG WOMEN AND 41 YOUNG MEN RESPECTIVELY. INDEPENDENT CITY, NOW IN ITS 15TH YEAR, PROVIDED 43 YOUTH WITH A MORNING OF ACTIVITIES TO REPLICATE THE ACTIVITIES AND DECISIONS THEY’LL NEED TO MAKE WHEN THEY TRANSITION FROM FOSTER CARE TO ADULTHOOD. HAD 107 ORANGEWOOD ADULT MENTORS INVEST 2,424 VOLUNTEER HOURS WITH THEIR MENTEES. EMPLOYMENT HELPED 133 YOUTH FIND JOBS. HELPED 181 YOUTH DEVELOP JOB-READINESS SKILLS THROUGH THE ASSISTANCE OF ORANGEWOOD STAFF OR VOLUNTEER MENTORS. PARTNERED WITH ORGANIZATIONS INCLUDING GOODWILL OF ORANGE COUNTY, HAVEN STAFFING, LEGAL AID SOCIETY, ORANGE COUNTY CONSERVATION CORPS, AND SANTA ANA WORK CENTER TO HELP OUR YOUTH FIND JOBS. HOUSING ORANGEWOOD WAS ESTABLISHED IN 1981 TO BUILD A SHELTER FOR ABUSED AND NEGLECTED CHILDREN IN ORANGE COUNTY. WHEN IT WAS COMPLETED, ORANGEWOOD CHILDREN’S HOME (NOW KNOWN AS ORANGEWOOD CHILDREN AND FAMILY CENTER) WAS DEEDED BACK TO ORANGE COUNTY SOCIAL SERVICES AGENCY TO OWN AND OPERATE. THE FOUNDATION CONTINUES TO SUPPORT THE SHELTER WITH VOLUNTEERS, SPECIAL ACTIVITIES FOR THE CHILDREN, AND FUNDING FOR OCCASIONAL SPECIAL PROJECTS. THE FOUNDATION PROVIDES HOUSING REFERRALS AND ASSISTANCE, PLUS TRANSITIONAL HOUSING THROUGH OUR THREE RISING TIDE PROGRAM SITES. AMONG YOUTH WHO VISIT OUR RESOURCE CENTER, 55% INDICATED THAT THEY HAD BEEN HOMELESS OR EXPERIENCED UNSTABLE HOUSING IN THE PAST SIX MONTHS. OUR NEWEST PROGRAM THE LIGHTHOUSE. ORANGEWOOD IS WORKING ON CREATING A NEW, RESIDENTIAL PROGRAM THAT WILL HELP SURVIVORS OF SEX TRAFFICKING IN ORANGE COUNTY RETURN TO A HEALTHY AND PRODUCTIVE LIFE. THE PROGRAM, CALLED THE LIGHTHOUSE, WILL BE STAFFED BY ORANGEWOOD EMPLOYEES WITH EXPERIENCE AND TRAINING IN WORKING WITH THESE VICTIMS, WHO UNDERSTAND THE POPULATION AND CAN OFFER THEM SPECIALIZED AND INDIVIDUALIZED SUPPORT DURING THE LAST YEAR, WE PROVIDED TRANSITIONAL HOUSING (18-24 MONTHS) IN THE RISING TIDE APARTMENTS AND HOUSE TO 55 FORMER FOSTER YOUTH, INCLUDING 11 MOTHERS AND THEIR 16 CHILDREN. PROVIDED CASE MANAGEMENT TO RISING TIDE RESIDENTS, ESPECIALLY IN THE AREA OF FINANCIAL LITERACY AND FINANCIAL RESPONSIBILITY. DURING THE YEAR 28 RESIDENTS REDUCED THEIR DEBT. ASSISTED ANOTHER 97 YOUTH IN FINDING HOUSING OR IMPROVING THEIR HOUSING SITUATION. WAYS TO GIVE MAKE A LASTING IMPACT IN A LIFE OF A YOUTH TODAY! HOW TO VOLUNTEER. THERE ARE MANY WAYS TO SUPPORT THE MISSION OF ORANGEWOOD.
