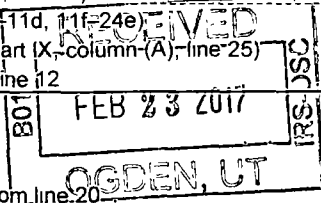

In partnership with their communities, non-governmental organizations, concerned shareholders and citizens, we utilized the following strategies. We campaigned to persuade decision-makers in corporations, international financial institutions and governments to honor the rights of indigenous peoples over decisions in their territories and to rectify past harms, including the impacts of oil drilling. Through media exposure, legal action, and shareholder campaigns, we promoted corporate social and environmental accountability. (Continued below)

4b (Code) (Expenses \$ including grants of \$) (Revenue \$) We continued to work to strengthen capacity in indigenous communities and partner organizations in the Amazon to better advocate for their own rights at local, national and international forums. Through training in legal rights, advocacy, media and technology, as well as the donation of equipment, we helped our indigenous partners protect their rainforest homelands, assert their collective voice and advance their rights to seek permanent protection for threatened areas and vulnerable indigenous populations in the Amazon rainforest. In partnership with ally organizations in South America, we continued to champion ecologically sound alternatives and solutions to industrial and fossil-fuel intensive economic development.
