PLANNED PARENTHOOD OF THE PACIFIC SOUTHWEST (PPPSW) PROVIDES A VARIETY OF REPRODUCTIVE HEALTH SERVICES TO ITS PATIENTS. DURING THE PERIOD JULY 1, 2015 - JUNE 30, 2016, PPPSW SAW MORE THAN 277,847 PATIENT VISITS IN ITS 17 HEALTH CENTERS. OVER 68% OF THOSE VISITS WERE PROVIDED TOPATIENTS WITH NO INSURANCE COVERAGE OTHER THAN GOVERNMENT-SPONSORED PROGRAMS. SERVICES INCLUDED 264,359 STI TESTS, 73,550 PREGNANCY TESTS, 177,491 CYCLES OF ORAL CONTRACEPTION MEDICATIONS, AND 38,535 CANCER SCREENINGS AND OTHER REPRODUCTIVE HEALTH SERVICES. THE ORGANIZATION PROVIDES CARE WITHOUT CHARGE, OR AT AMOUNTS LESS THAN ITS ESTABLISHED RATES, TO PATIENTS WHO MEET CERTAIN CRITERIA. CHARGES FOREGONE FOR SERVICES FURNISHED BY THE ORGANIZATION TOTALED APPROXIMATELY \$1,084,000 IN THE YEAR ENDED JUNE 30, 2016.
