ALL KAMEHAMEHA STUDENTS ON THE KAPALAMA CAMPUS MAY APPLY FOR ENRICHMENT GRANTS. IN ACCORDANCE WITH THE BYLAWS, GRANT FUNDS ARE APPROPRIATED BY THE EXECUTIVE COUNCIL TO ELEMENTARY, MIDDLE, AND HIGH SCHOOL. EACH UNIT'S COUNCIL CONSISTS OF ELECTED PARENT REPRESENTATIVES, SCHOOL FACULTY, AND ADMINISTRATIVE STAFF. THESE COUNCILS REVIEW GRANT APPLICATIONS AND RENDER AWARDS BASED ON THE MERITS OF THE PROPOSAL.

FUNDED PROGRAMS TO ENGAGE PARENTS AND ENCOURAGE THEIR INVOLVEMENT AND PARTICIPATION IN SCHOOL ACTIVITIES SUCH AS CLASS PICNICS, SPIRIT NIGHT, AND OTHER PRESENTATIONS. TO ENSURE THAT ALL STUDENTS OF THE KAPALAMA CAMPUS RECEIVE BENEFITS FROM KS ATP, A \$4 PER STUDENT FUND WAS CREATED (THE AMOUNT WAS RAISED FROM \$2 TO \$4 IN FY 2008). TYPICAL USES OF THESE MONIES INCLUDE VARIOUS ATP ACTIVITIES SUCH AS MOVIES AND CLASS PICNICS. THESE FUNDS ARE ACCESSED VIA THE PARENTS AND ALUMNI RELATIONS OFFICE. IN ADDITION, KS ATP PROVIDES SEVERAL SERVICE PROGRAMS INCLUDING SPIRIT NIGHT AND SUNSET ON KONIA.

PROVIDED EDUCATIONAL NECESSITIES SUCH AS SCHOOL UNIFORMS AND SUPPLIES TO INDIGENT STUDENTS IDENTIFIED BY TEACHERS AND COUNSELORS. INDIGENT STUDENTS MAKE UP A SIGNIFICANT PORTION OF THE STUDENT BODY. THE KOKUA FUND SERVES STUDENTS WITH INDIGENT BACKGROUNDS WHO HAVE SPECIAL OR EMERGENCY FINANCIAL NEEDS. THE FUND IS ADMINISTERED BY THE ASSISTANT TREASURER WHO IN TURN RECEIVES REQUESTS AND RECOMMENDATIONS FROM THE RESPECTIVE PRINCIPALS, VICE PRINCIPALS, AND COUNSELORS. \$4,232 IN DONATIONS WERE RECEIVED IN FY 2015 FOR THE KOKUA FUND. TYPICAL USES FOR THE FUND INCLUDE GRANTS TO NEEDY STUDENTS WHO CANNOT AFFORD DRESS WHITES, SHOES, SCHOOL UNIFORMS, SCHOOL SUPPLIES, OR TO PAY MINOR OUTSTANDING TUITION BALANCES AT YEAR END. ALTHOUGH ALL OF THE RECIPIENTS ARE ON FULL FINANCIAL AID, FINANCIAL AID LIMITATIONS DO NOT COVER THESE TYPES OF EXPENDITURES.

RE Kamehameha Schools Association of Teachers and Parents FEIN 99-0175487 Form 990, Fiscal year ended June 30, 2016 Request for abatement of penalties for late filing of return We are enclosing the form 990 for the above referenced entity and tax period We acknowledge that enclosed for 990 is being submitted after the required date for filing the return According to instructions for filing form 990, the return should be filed by the 15th day of the 5th month following the end of the fiscal year The instructions indicate that we should have filed for an extension of time to file the form 990 by submitting a form 8868, Application of Extension of Time to File and Exempt Organization Return An extension was not filed for the above referenced entity for the year ended June 30, 2016 The instructions to the form 990 indicates that under IRC section 6652(c)(1)(A) a penalty can be charged when a return is filed late, unless the organization can show that the late filing was due to reasonable cause We believe that reasonable cause exists for the late filing of the enclosed form 990 We therefore request no penalty relating to the late filing of the enclosed form 990 be charged against the organization

Facts The person responsible for preparing the form 990 is the Assistant Treasurer of the organization I, Patricia A Matsumoto, was hired as the Assistant Treasurer in July 2015 The former Assistant Treasurer continued to be employed for a period of time after I was hired in his place The former Assistant Treasurer had been in his position for more than 30 years The extension of time to file the form 990 for the previous fiscal year (ending June 30, 2015) was prepared and filed by the former Assistant Treasurer At a meeting of executives in February 2016, the Treasurer mentioned the requirement to complete the form 990 before the deadline of February 15, 2016 After reading the instructions to the form 8868, I understood that the filing of the form could be further extended to May 15, 2016 Although records were not well kept, my staff and I were able to make sense of the transactions and compiled information necessary to prepare the form 990 with complete and accurate data and other information We filed the form 990 for the period ending June 30, 2015 (the previous year) by May 15, 2016 My predecessor did not keep a calendar of events that included the filing deadline for the form 990 for the organization by November 15, 2016 As a result, the initial filing deadline was overlooked by our office During February of this year (2017) I became aware of the prior year February 2016 discussion regarding the filing deadline for the form 990 I then realized that initial extension of time for filing form for the enclosed form 990 for the fiscal year ended June 30, 2016 was not filed I made it a priority to have my staff compile the information necessary to prepare a form 990 for the fiscal year ended June 30, 2016 in a complete and accurate manner I believe that the information contained on the enclosed form 990 is complete and accurate for the period indicated I have made sure that the Treasurer, myself (Assistant Treasurer), and the Administrator have put on a recurring calendar the due date (November 15) for the filing of the annual form 990 for the organization I have further implemented accounting procedures to make use of accounting software to account for transactions for the organization Formerly, the data was maintained manually with little structure which made it difficult to compile the information required to prepare a complete and accurate form 990 Reasonable cause exception We believe that reasonable cause exists because of 1) There was no intentional disregard of the rules for timely filing the form 990 2) The Treasurers' office was not aware of the filing deadline Instead, the organization had relied on the form Assistant Treasurer (who had been in his position for 30 years ending in 2015) 3) Immediately upon realizing the oversight of filing the initial extension, this office made every attempt to compile the information in a manner to prepare the enclosed form 990 in a complete and accurate manner 4) We have put in place procedures to ensure that the time for filing the return or the time for filing the extension in the future will never again be missed 5) We have updated our procedures to not only ensure that due dates are not missed but also improved our accounting for transactions that should be reported on the form 990 Conclusion Based on the above, we believe that reasonable cause does exist for the late filing of the enclosed form 990 for the above referenced organization and fiscal year There was never an intentional disregard of the rules for the timely filing of the enclosed form 990 We have put in place policies and procedures to ensure that the deadline is not missed in future years We therefore request that you do not assess penalties for the late filing of the enclosed return If you should have any questions regarding any of the above, please contact me by email at pamatsum@ksbe.edu or by phone at (808) 842-8552 Sincerely, Patricia A Matsumoto Assistant Treasurer
