FORM 990, PART III, LINE 4A, PROGRAM SERVICE ACCOMPLISHMENTS	THE MEDIATION CENTER OF THE PACIFIC (THE MEDIATION CENTER) IS A 501(C)(3) NOT FOR PROFIT CORPORATION THAT WAS FOUNDED IN 1979 TO PROVIDE HAWAII'S PEOPLE WITH PEACEFUL APPROACHES TO WORKING THROUGH CONFLICT. THE MEDIATION CENTER WAS ONE OF THE EARLIEST ESTABLISHED COMMUNITY MEDIATION CENTERS IN THE NATION, AND IT HAS CONTINUED TO GROW AND EVOLVE SINCE THAT TIME. THROUGH A VARIETY OF CULTURALLY SENSITIVE PROCESSES, PEOPLE FROM ALL FACETS OF HAWAII'S COMMUNITIES, YOUNG AND OLD, ARE HELPED TO PREVENT AND RESOLVE CONFLICT. CONFLICT CAN TEAR FAMILIES APART, LEAD TO HOMELESSNESS, DEPRESSION, LOSS OF WORK AND MORE. MEDIATION AND OTHER DISPUTE RESOLUTION SERVICES PROVIDED THROUGH THE MEDIATION CENTER ALLOW FAMILIES, FRIENDS, CO-WORKERS, NEIGHBORS, LANDLORDS AND TENANTS AND MANY OTHERS, THE OPPORTUNITY TO SIT DOWN WITH A TRAINED MEDIATOR IN A NON-THREATENING SETTING TO TALK AND NEGOTIATE CREATIVE SOLUTIONS. WHILE PEOPLE WITH FINANCIAL RESOURCES HAVE MULTIPLE OPTIONS TO ADDRESS THEIR CONFLICTS, THE MEDIATION CENTER IS THE ONLY DISPUTE RESOLUTION OPTION FOR PEOPLE IN THE LOW INCOME AND VULNERABLE POPULATIONS ON OAHU. IN GENERAL, THE MEDIATION CENTER WORKS WITH OTHER LEGAL SERVICE PROVIDERS, THE COURTS AND THE COMMUNITY TO OFFER A BROAD ARRAY OF MEDIATION, TRAINING AND DISPUTE RESOLUTION SERVICES TO MEET COMMUNITY NEEDS INCLUDING - COMMUNITY MEDIATION SERVICES FOR THOSE IN DISPUTE WITH FAMILY MEMBERS, NEIGHBORS, COWORKERS AND FRIENDS - SPECIALIZED MEDIATION SERVICES, INCLUDING DIVORCE, CUSTODY, EMPLOYMENT, CIVIL RIGHTS, CONDOMINIUM, SPECIAL EDUCATION, LANDLORD/TENANT, FORECLOSURE, ADULT GUARDIANSHIP, CAREGIVING, AND CONSUMER/MERCHANT - ON-SITE COURT MEDIATIONS INCLUDING THOSE FOR SMALL CLAIMS, SUMMARY POSSESSION, PATERNITY AND TEMPORARY RESTRAINING ORDERS - MEDIATION AND FACILITATION TRAINING FOR SCHOOLS, INDIVIDUALS, BUSINESSES, NON-PROFITS, AND GOVERNMENT AGENCIES. THE TRAININGS ARE DESIGNED TO HELP THE PARTICIPANTS DEVELOP EFFECTIVE COMMUNICATION, CONFLICT RESOLUTION AND MEDIATION SKILLS - IN-HOUSE TRAINING FOR THE MEDIATION CENTER'S NEARLY 150 MEDIATORS WHO PROVIDE THEIR SERVICES PRO BONO, TOTALING MORE THAN 3,000 HOURS ANNUALLY. MEDIATORS MUST PARTICIPATE IN ON-GOING WORKSHOPS AND LECTURES TO KEEP THEIR SKILLS HONED AND TO LEARN NEW TECHNIQUES. THESE CONTINUING EDUCATION PROGRAMS ARE PROVIDED FREE-OF-CHARGE. THE MEDIATION CENTER'S APPROACH AND CULTURALLY SENSITIVE MODEL OF MEDIATION IS PARTICULARLY WELL SUITED FOR PEOPLE IN CONFLICT WHO HAVE CONTINUING RELATIONSHIPS. IT IS FOR THIS REASON THAT THE MEDIATION CENTER HAS BEEN SUCCESSFUL IN ASSISTING UNMARRIED EX-COUPLES TO AGREE ON CO-PARENTING PLANS FOR THEIR CHILDREN, SIBLINGS TO AGREE ON TRANSITION AND CAREGIVING PLANS FOR ELDERLY PARENTS, PAYMENT PLANS BETWEEN LANDLORDS AND TENANTS, AND MORE. THE FEEDBACK PROVIDED ON THE MEDIATION CENTER'S QUALITY SURVEY QUESTIONNAIRES COMPLETED BY THE PARTICIPANTS UPON THE CONCLUSION OF THEIR MEDIATION SESSION HAS HISTORICALLY BEEN OVERWHELMINGLY COMPLEMENTARY. PARTIES ARE TYPICALLY VERY THANKFUL FOR THE SERVICES RECEIVED AND WISH THAT THEY HAD KNOWN ABOUT MEDIATION SOONER. DURING THE PAST FISCAL YEAR, 96% OF SURVEY RESPONDENTS AGREED THAT MEDIATION IS A USEFUL PROCESS. MOREOVER, THE VAST MAJORITY OF PARTICIPANTS EXPRESS THEIR INTENT TO USE MEDIATION TO RESOLVE DISPUTES IN THE FUTURE. A TESTAMENT TO THEIR BELIEF IN THE UTILITY OF MEDIATION, A FULL 83% OF SURVEY RESPONDENTS AGREED THAT THEY WOULD USE MEDIATION TO RESOLVE FUTURE PROBLEMS. IN FISCAL YEAR 2015-2016, THE MEDIATION CENTER SERVED 7,935 INDIVIDUALS THROUGH ITS MEDIATION, DISPUTE RESOLUTION AND TRAINING PROGRAMS. ALTOGETHER, A TOTAL OF 1,743 MEDIATIONS AND FACILITATIONS WERE MANAGED DURING THE YEAR. OF THE 1,173 CASES THAT WERE MEDIATED OR FACILITATED, 52% RESULTED IN WRITTEN AGREEMENTS. MORE SPECIFICALLY, 328 DIVORCE MEDIATIONS WERE MANAGED WITH 62% OF THE MEDIATED DIVORCE CASES RESULTING IN WRITTEN AGREEMENTS, 235 CUSTODY MEDIATIONS WERE MANAGED BOTH IN-HOUSE AT THE MEDIATION CENTER AND ON-SITE AT COURT, WITH 64% OF THE CASES RESULTING IN WRITTEN AGREEMENTS, 37 KUPUNA PONO MEDIATIONS AND FAMILY CONFERENCES WERE MANAGED WITH 91% RESULTING IN WRITTEN AGREEMENTS AND FAMILY PLANS, AND 420 LANDLORD/TENANT MATTERS WERE MANAGED BOTH IN-HOUSE AT THE MEDIATION CENTER AND ON-SITE AT COURT, WITH 46% RESULTING IN WRITTEN AGREEMENTS. IN ADDITION TO PROVIDING DIRECT MEDIATION AND DISPUTE RESOLUTION SERVICES, THE MEDIATION CENTER IS A CRITICAL RESOURCE FOR CREATING INNOVATIVE DISPUTE RESOLUTION TRAININGS AND PROGRAMS FOR HAWAII'S COURTS, SCHOOLS, BUSINESSES AND COMMUNITIES. THROUGH THESE TRAININGS AND PROGRAMS, MORE PEOPLE HAVE THE OPPORTUNITY TO WORK THROUGH THEIR CONFLICTS AND AVOID A LEGAL OR ADMINISTRATIVE PROCEEDING. A FEW EXAMPLES OF THESE PROGRAMS INCLUDE A DIVORCE MEDIATION PROGRAM THAT HELPS DIVORCING COUPLES FOCUS ON THE "BEST INTERESTS" OF THEIR CHILDREN WHILE REACHING DECISIONS TO FINALIZE THEIR DIVORCE, A SPECIAL EDUCATION DISPUTE RESOLUTION PROGRAM THAT OFFERS MEDIATION TO ADDRESS DISPUTES ARISING BETWEEN PARENTS OF CHILDREN WITH SPECIAL NEEDS AND SCHOOL PERSONEL, AND THE KUPUNA PONO PROGRAM THAT PROVIDES MEDIATION AND FAMILY CONFERENCING TO HELP FAMILIES CARING FOR AN ELDER MEMBER ENGAGE IN DIFFICULT CONVERSATIONS AND AGREE ON PLANS THAT SUPPORT THE NEEDS OF THE ELDER MEMBER. IN FISCAL YEAR 2015-2016, THE MEDIATION CENTER CONDUCTED 175 HOURS OF TRAININGS AND WORKSHOPS FOR THE MEDIATORS, INDIVIDUALS, BUSINESSES, GOVERNMENT AGENCIES AND OTHER NON-PROFIT CORPORATIONS THROUGHOUT THE STATE. THE MANY OPPORTUNITIES PROVIDED BY THE MEDIATION CENTER TO PREVENT AND RESOLVE DISPUTES QUICKLY AND AFFORDABLY THROUGH CULTURALLY SENSITIVE PROCESSES ARE A VITAL RESOURCE FOR HAWAII'S RESIDENTS. THANKS TO CONTINUING SUPPORT FROM GENEROUS DONORS AND SUPPORTERS, THE MEDIATION CENTER CONTINUES TO STRENGTHEN CURRENT PROGRAMS, AS WELL AS CREATE NEW PROGRAMS TO ADDRESS CURRENT COMMUNITY NEEDS.
