BISHOP DESIRED THAT THE INDIVIDUALS SERVING AS TRUSTEES OF THE CRBT BE THE SAME INDIVIDUALS SERVING AS TRUSTEES OF THE TRUST CREATED UNDER THE WILL OF HIS WIFE, KE ALI'I BERNICE PAUHI BISHOP, KNOWN AS KAMEHAMEHA SCHOOLS (KS). THE PARTIES HAVE RESPECTED MR. BISHOP'S DESIRE FROM THE BEGINNING OF THE CRBT. AS A RESULT, THE COMPENSATION REFLECTED IN PART VII, SECTION A, IS THE COMPENSATION THAT THE TRUSTEES RECEIVE IN THEIR ROLE AS TRUSTEES OF KS. THEY HAVE WAIVED AND RECEIVE NO PAID COMPENSATION FROM THE CRBT.
