Immigration PolicyThe NYC works to identify and break down barriers to equality and justice, focusing on strategic issues affecting immigrants on the federal, state, and local levels - including but not limited to comprehensive immigration reform, tuition equity, immigration enforcement, and detention Training & Legal ServicesThe NYC reaches thousands of legal service providers and nonprofit staff each year through training, liaison work, and technical assistance - effectively enhancing the availability of quality legal services for immigrants across New York State In fiscal year 2016, the NYC offered hundreds of hours of trainings on topics critical to legal service providers and other organizations across New York State, including several trainings on Board of Immigration Appeals Recognition & Accreditation The NYC also provides crucial service coordination and responds to crises and changing circumstances for example, after successful advocacy to achieve Temporary Protected Status (TPS) for Nepali citizens in the wake of a devastating earthquake, the NYC worked with legal service providers and a Nepali-led community-based organization in Queens to hold legal clinics and assisted hundreds of individuals with TPS applications The NYC's legal initiatives team also liaises with law enforcement and service providers to protect community members from immigration services fraud, and advocates for both New York City and State to increase funding for legal services and better protect immigrants from fraud Education ReformThe NYC advocates to improve the quality of education for New Yorks English Language Learner (ELL) and immigrant students, and to promote opportunities for parents to meaningfully engage in their childrens education Health Care AccessThe NYC works to ensure that all immigrants and limited English proficient (LEP) New Yorkers have access to safe and quality health care Civic & Electoral ParticipationThe NYC works to achieve more democratic and participatory political and civic processes The NYC hosts an annual Student Voter Registration Day in high schools across New York City which registered more than 8,000 high school seniors in March 2016 as well as a statewide, nonpartisan Immigrants Vote! Campaign which engaged 40,000 and registered 10,000 voters throughout 2016 The NYC also advocates along with our Civic Engagement Collaborative for crucial voting reforms in New York State, expanded participatory budgeting in New York City, increased translations of voter registration forms, and more Regional AdvocacyThe NYC engages local member organizations from Long Island, the Hudson Valley, Buffalo, Rochester, Syracuse, and other areas through advocacy, training, and service coordination to address the needs of immigrants outside of New York City

National Immigrant Integration Conference & Special Projects The NYC co-hosted the 2015 National Immigrant Integration Conference (NIIC), New American Dreams Advancing Opportunity, Equality & Justice in Brooklyn on December 13-15, 2015 The largest gathering on immigration in the U S , NIIC 2015 was the biggest yet, brnnging together 1,400 participants members of the policy, business, nonprofit, labor, academic, faith, community and philanthropic sectors from across the country to build solutions around immigrant integration The conference had 11 tracks with dozens of breakout sessions and special sessions, including many new tracks such as Business & Financial Empowerment and Academic Perspectives The NYC was particularly thrilled to welcome Senator Chuck Schumer, Representative Luis Gutierrez, Governor Andrew Cuomo, Mayor Bill de Blasio and the Mayors Office for Immigrant Affairs Commissioner Nisha Agarwal to address participants, among many other highly distinguished speakers NYC remains involved in planning this national conference, but will not host again in the near future as the venue rotates annually The NYC develops and implements unique community-based initiatives and campaigns to engage, empower and holistically integrate immigrant communities in New York City and State This includes the NYCs signature Key to the City initiative, which brngs consulates, legal service providers, and other providers to local community-based school sites monthly to provide photo IDs, legal screenings, and other services to New York Citys hardest-to-reach populations In fiscal year 2016, more than 2,000 individuals received services through Key to the City The NYCs Black Immigrant Engagement Initiative, launched in the spring of 2016, works to engage New Yorks African, Afro-Latino, and Afro-Caribbean communities in advocacy, connect them with crucial legal services, and build the capacity of the organizations that serve these communities Lastly, the NYCs Mexican Initiative for Deferred Action - which worked to promote Deferred Action applications and the upward integration of New York States Mexican community - served over 800 individuals
