VE Global (VE) fosters the development of children at social risk in Chile by training and empowering volunteers to serve as positive role models, educators, and advocates of social justice. VE Global recruits, selects, trains, and provides support to a corps of 20-30 volunteers and interns annually. VE Global volunteers and interns come from all over the world to support VE's mission and vision, providing support to VE Global Chile and its local partner organizations in Santiago, Chile. Volunteers and the VE Global Chile team create and implement a series of engaging, innovative educational and recreational programming for children and youth living in vulnerable and marginalized situations. VE Global Chile's partner organizations include residential group homes for children and youth, a community center, and a school for children with developmental and learning challenges. VE Global also supports local youth in Santiago through a new program called Soy Independiente, a series of workshops that provide social emotional and life skills training to youth living in residential group homes. VE Global Chile implements 5 main projects through its volunteer program in Santiago, Chile:

- 1) Vamos a Leer: a summer motivational and educational reading program;
- 2) Liga de Deportes: a monthly health and wellness sports league;
- 3) Festival de Arte: biannual art and performance exhibitions with a series of art workshops and events prior to the exhibition;
- 4) English in Motion: Dynamic English language workshops throughout the academic year;
- 5) Original Volunteer Workshops: Volunteers plan and execute a variety of creative, innovative educational and recreational workshops with children and youth in order to support their social emotional learning and skill building.

Fulltime VE Global volunteers work in Chile for a minimum volunteer commitment of four months, successfully ensuring their integration into local VE Global Chile partner organizations, thus providing support as much-needed human resources in the existing child and youth welfare system in Chile. VE Global volunteers are required to commit to a four-month minimum commitment to ensure that the volunteers have a positive effect in the lives of the children and youth serviced by its programming.

Line 28, Expenses/Grants (\$38,798), Program Service Accomplishments

VE Global provides grant funding to VE Global Chile to support the selection, training, and ongoing in-country support of international volunteers in Santiago, Chile. Grant funding also supports innovative program initiatives like VE Global Chile's new Soy Independiente Life Skills training program for youth living in residential group homes that will be transitioning to independent living. VE Global Chile provides roughly 30,000-35,000 hours of support every year to its local partner organizations through its donated volunteer and intern labor. VE Global Chile currently partners with residential group homes that provide child welfare services to children and youth that have been separated from their families of origin by the Chilean family court system. In addition to these residential group homes, VE Global Chile also partners with a school for children with developmental and learning challenges and a neighborhood community center, both located in socio-economically marginalized and vulnerable communities in Santiago, Chile.

VE Global Chile has had a successful year, supporting more than 300 children and youth through its volunteer and life skills programs. Volunteers and interns receive training throughout the year, including VE Global's signature initial Orientation program, conducted for all new incoming volunteers in January, May, and September. Volunteers went on to successfully implement VE Global Chile's five educational and recreational programs over the course of the year, which help fulfill VE Global's mission of fostering the social and emotional development of children and youth at social risk in Santiago, Chile. This corps of volunteers and interns serve as positive role models, educators, and advocates of social justice, making a positive impact in the lives of many Chilean children and youth every year.
