ECAL Inc established Caring Communities in 2008 to transform program philosophy and practice in child care setting for infants and toddlers. The initiative has successfully implemented programs in 12 sites in central Ohio and one site in Cincinnati, Ohio through training and mentoring of center teachers and directors. Seven group trainings were offered to 45 teachers, along with at least 100 mentor visits in teacher classrooms from 7 experienced and skillful master teachers. The CC B-3 initiative has assisted in improving over all center quality, with several centers receiving increase quality ratings from the state's Step Up to Quality child care center rating system. CC B-3 impacts on the quality of care for over 200 infants and toddlers in child care centers in central Ohio during this reporting year. All centers who have made the commitment to transform their programs from individual groups of younger infants, older infants and toddlers to mixed age communities of infants and toddlers together have maintained that program model despite issues of funding challenges because they understand the added value to young children in a mixed age class with continuing, primary teachers. Beginning in August 2015, ECAL Inc /CC B3 began participating in a new Early Head Start partnership established at The Ohio State University Research Center. The partnership includes the local public housing agency, Nationwide Children's Hospital, and agencies for children with disabilities among others. The full day child care services are provided by CC B-3 centers and home care providers. As an OSU/EHS partner, CC B-3 provides services to help insure the educational EHS program is of high quality. New centers who might join the EHS program must use the CC B-3 mixed age, primary care model.
