Bottomland Forest Survey Project: \$3,956.02

A contract initially funded in FY 2015 with the Missouri Department of Conservation to perform bird surveys in restored forests of southeast Missouri. Very little bottomland forest remains in the state, and MDC foresters are working to conserve and improve key areas in several watersheds, including the Mississippi River drainage. Bird survey data will provide feedback to foresters on restoration success.

St. Joe State Park Survey Project: \$3,141.76

A contract with the Missouri Department of Natural Resources to perform bird surveys in various management units of the DNR's St. Joe State Park. These surveys will provide feedback on success of management to maintain or increase avian biodiversity. Survey work was performed in FY2016; funds will be received during FY2017.
