It has an independent board, but the accounting and board deliberations are transparent to The Small Things Inc. On review it is apparent that the money for the purchase of the land was made as a grant to The Small Things TZ (Tanzanian sister organization) who purchased the land and is the owner of the land. This report therefore does not list the land as an asset of The Small Things Inc.

There is full transparency between the operations of The Small Things TZ and The Small Things Inc with a common executive director hired by TST inc and full access to the accounts and Board activities of TST TZ. TST TZ is registered in Tanzania and recognized as a charitable operation in that country. There is an annual audit process of funds provided to TST TZ and the findings of that audit are available and reviewed by TST Inc.
