Some of SPARTAN's recent achievements have been the development of treatment guidelines for axial spondyloarthritis along with the American College of Rheumatology and the Spondylitis Association of America, researching the epidemiology of axial spondyloarthritis with the National Health & Nutritional Examination Survey, and conducting the CME (continuing medical education)-accredited educational symposia along with the Group for the Research and Assessment of Psoriasis and Psoriatic Arthritis in nearly 20 cities around the United States.
