Culinary Partners was created to meet the purchasing, training and support needs of school district food service programs.

Culinary Partners works with partner school districts to 1) assess food service program strengths, weaknesses and opportunities and will develop recommendations for action that each district can pursue to increase quality, efficiency or other aspects of school food service and delivery; 2) either facilitate training partnerships with culinary institutes or provide customized culinary training for cafeteria staff; and 3) provide a network to share recipes and menu rotations and successes and pitfalls to serve as an avenue for problem solving.

Form 990, Part III, Line 4a - Program Service Accomplishments

Culinary Partners collaborated with Spartanburg District 6 and Greenville Technical College to train 91 school food service staff members in 2014 to prepare for a district-wide overhaul of the cafeteria program. The District committed to increasing the quality of the food and preparing scratch-made, healthy and tasteful recipes that students and faculty enjoyed. The training was a success, as was the launch of the program at the beginning of the school year. District 6 administrators reported that food sales were up in the first two months of the school year.

In 2015, Culinary Partners expanded its training and support services to the Pee Dee. Through a partnership with the Culinary Arts Department at Horry Georgetown Technical College, approximately 40 cafeteria staff from Georgetown County Schools enthusiastically completed a week of training.

A USDA grant award, announced in September 2015, will provide two years of funding to train approximately 450 cafeteria staff in public schools primarily located in the Pee Dee and Low Country areas of South Carolina. In addition to training, the grant would provide funding to develop a menu bank and provide more in-depth training in marketing, promotions and food/product development. Culinary Partners is pleased to partner with the SC Department of Education and Cornell University to complete the project.

In the summer of 2016, five districts, Barnwell, Darlington, Florence 1, Georgetown and Jasper participated in training through the Team Nutrition Grant. In addition, the State Department of Education funded a training in Laurens School District 55 in which employees from Laurens 55, Laurens 56, Union and Will Gray School attended. An additional training in Richland 1 covered topics in HACCP, marketing, culinary skills and math. A total of 270 employees were trained.
