Solstice Initiative began its work on the ground in Massachussets in mid-2015. We worked with four solar developer partners on five community solar projects across central and southeastern MA, enrolling 15 customers, including one house of worship. We engaged with nearly 400 households across the state of MA educating them about community solar, namely how it works, how it can help them save money on their electricity bills, and how they can sign up. We also began building out our team, bringing on several full-time hires to help primarily with community outreach. Finally, we received funding from the Echoing Green Fellowship, Ittleson Foundation, Godley Family Foundation, ONE Foundation, JMK Fund, and Susan Crown Exchange, and participated in the CleanTech Open Northeast and MIT Delta V accelerator programs.
