member. In addition, 6 college freshman received \$1,000 for engineering study, \$9,5000 in scholarships were awarded to students
selected by their chapters, and two students received partial fellowships totalling \$9,500.

Published a quarterly magazine with a circulation of over 90,000 for members. Features include news of the

Held national and regional meetings of its members where collegiate chapter officers receive leadership training,

volunteers and funds to other charities. Grants included \$1,797 to support K-12 STEM projects in local school districts
across the country.
