The university is comprised of five colleges: Business, Arts and Sciences, Law, Music and Fine Arts, and Graduate and Professional Studies. Loyola offers 59 undergraduate degrees and 11 graduate and professional programs. In addition, the university offers over fifty study abroad programs that include, but are not limited to, programs in Belgium, Brazil, China, Ecuador, France, India, Ireland, Japan, Korea, Italy, Netherlands, Spain, U.K., and more.
