THE FOUNDATION LAUNCHED ITS MENTOR PROGRAM IN FEBRUARY 2006 FOR CHILDREN WHO ARE AFFECTED BY THE INCARCERATION OF ONE OR BOTH OF THEIR PARENTS. THE FOUNDATION RECRUITS VOLUNTEERS FROM THE COMMUNITY, MATCHES THEM WITH ELIGIBLE CHILDREN, AND OFFERS ONGOING SUPPORT TO BOTH CHILDREN AND MENTORS. THE MENTORS PROVIDE STABLE, LONG-TERM RELATIONSHIPS FOR THE STUDENTS AND HELP THEM DEVELOP AND MAINTAIN POSITIVE ATTITUDES TOWARDS SCHOOL. DURING THE 2015/2016 SCHOOL YEAR, SEEDLING MATCHED AND SUPPORTED 623 STUDENTS IN K-12. 63% OF THESE CHILDREN WERE IN ELEMENTARY SCHOOL, 29% IN MIDDLE SCHOOL AND 8% IN HIGH SCHOOL. THE CHILDREN MENTORED WERE OVERWHELMINGLY FINANCIALLY DISADVANTAGED AND CHILDREN OF COLOR. IN ALL, DURING THE SCHOOL YEAR, 119 SCHOOLS IN 7 SCHOOL DISTRICTS AND 17 CHARTER SCHOOLS WERE SERVED.
