Scientific Programs MSRI conducts broadly-based research programs in the mathematical sciences and closely related fields In any given year, MSRI conducts between two and four thematic research programs, each lasting either 5 months or 10 months Each such program hosts 40-100 mathematical scientists from all over the world whose research centers on the program's theme, during which time, they collaborate on research, conduct seminars and workshops, and train and mentor postdoctoral fellows in the discipline MSRI also hosts, each year, several stand-alone workshops on special topics, each one lasting for a period between one day and two weeks and bringing to MSRI between 40 and 150 participants MSRI also collaborates with other mathematics institutes in scientific programs and in its efforts to encourage a diverse population to participate in mathematics research programs

Math and Society Programs MSRI sponsors a large number of programs and activities whose goal is to enhance K-12 mathematics education and teacher training These include supporting the National Association of Math Circles (which promotes a math circles nationwide, mathematics related events for children (the Bay Area Mathematics Olympiad), Circle on the Road (a program to foster establishment of new math circles), Critical Issues in Mathematics Education (a forum for exchange of ideas between mathematics researchers and educators) In addition, each year, a series of films, and public lectures and other events are hosted at MSRI and throughout the country for the public That helps the interested lay person to understand the importance of mathematics and its applications in our society and culture and to appreciate the significant recent advances in the discipline
