Nicaragua - We built two classrooms at 15th Septiembre School in Matagalpa
Nepal - We built seven birthing centers providing pre-, neo-, and post-natal care to birthing mothers. They are reducing the number of women dying in childbirth by more than 90%. We also inoculate the babies at birth against eleven of the most common diseases. We have begun work on three more birthing centers, in Mulpani, Kasteem and Kot villages, Tembisa township, South Africa. We have refurbished 15 pre-schools, including jungle gyms and water systems. Student travelers refurbished 5 pre-schools improving the condition and the reception for the hundreds of students who will attend them over their lives. Manyesa, Malawi. We arranged for four classrooms, nine teachers and a solar powered computer lab for 1200 children. Nyeri, Kenya. We built a set of private toilets for girls in Ngungu day Secondary School. Indonesia. Water supply to residents is affected by E. coli from human waste. We are building forty-seven engineered toilets to eradicate this problem. Myanmar. We are building a small medical clinic to address malnutrition, vaccinations, infections, small injuries and hygiene to assist 230 orphans adopted by Buddhist temple. (Grants \$ 58,560)
