IN ANY EVENT, UNDERTAKING A LARGE GUARANTEE IS A POWERFUL DEMONSTRATION OF HOW THE ORCHESTRA COUNTS ON THE FUND FOR CRITICAL SUPPORT FOR ITS EXISTENCE - AND HOW THE FUND HAS RESPONDED TO THE NEEDS AND DEMANDS OF THE ORCHESTRA.
