These grants range from \$5,600 to over \$1 million and are renewable for two additional years contingent upon ArtsWave's successful fundraising effort and the organization meeting the requirements. Four different grantmaking committees comprised of community volunteers are responsible for the review of annual applications or interim reports. Committee members meet annually with all Sustaining Impact organizations.
