For grants, checks are not mailed with award letters. Grants are issued by paying vendors directly. Scholarships are awarded once a year (Spring). Calculations are prepared for all endowment funds for the next year showing availability and plays a role in the budget process. In January, the Foundation notifies the school how much money is available for scholarships. School counselors or committees are established that identify the students available for scholarships. Scholarship applications are submitted to the counselors or the foundations for the committees. Recommendations are made by the counselors or committees which then goes to the Board for approval.
