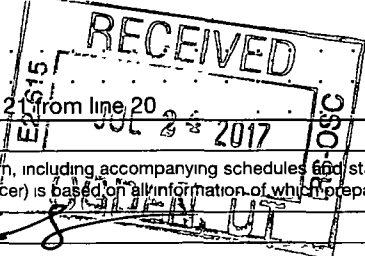

 During fiscal year 2015-2016, Live It Learn It (i) delivered more than 550 academic sessions for nearly 2,000 students (a year-over-year increase of 7% in students served), and (ii) trained nearly 60 current and future classroom teachers to conduct Live It Learn It programming on their own. Average student achievement nearly tripled from pre to post assessment, and achievement levels for the top 80% of our students more than quadrupled. Growth levels were highest in Wards 7 and 8, Washington, DC's two Wards with the lowest levels of average family income
