During this fiscal year PAMSEF continued supporting the Chincha Medical Center, adding specialties needed in the area like Occupational Medicine; the Center is open 7 days a week to care for indigent patients. PAMSEF sponsored 25 medical missions in Iquitos, Yantalo, Cusco, Ayacucho, Chorrillos, Collique, Pisco, Chincha, Santiago de Chuco and Huancavelica/Lircay. Funds were collected to help an orphanage and the maternity unit in the Chiclayo Regional Hospital and to renovate/update the School of Medicine of San Fernando in Lima. During PAMSEF's annual convention, a Scientific Program was presented to local students and physicians. A program of monthly video conferences has been established, presenting medical updates in various fields.
