EVERYONE WITH HIV IS ABLE TO ACCESS THESE SERVICES, REGARDLESS OF THEIR ABILITY TO PAY. IN 2015, ARCW PROVIDED \$3,127,667 OF UNCOMPENSATED CARE. MORE THAN 90% OF PATIENTS RATE THE CARE THEY RECEIVE AS GOOD OR VERY GOOD. THE ARCW MEDICAL CENTER IS WISCONSIN’S LARGEST AND MOST COMPREHENSIVE PROVIDER OF HEALTH CARE TO HIV PATIENTS.
