TO FACILITATE THIS BELIEF, EACH STUDENT S COGNITIVE, ACADEMIC AND SOCIAL STRENGTHS AND WEAKNESSES ARE IDENTIFIED, AND AN INDIVIDUAL EDUCATIONAL PROGRAM IS DESIGNED. THESE SERVICES INCLUDE DIAGNOSTIC TESTING, TUTORING, ASSISTIVE TECHNOLOGY ASSESSMENTS AND CONSULTS, SPEECH AND LANGUAGE ASSESSMENTS AND THERAPY, AND CAREER AND POST-SECONDARY COUNSELING.
