The Minnesota Justice Foundation is a nonprofit, nonpartisan organization of law students and attorneys that educates and encourages its members and the legal community in their professional obligation to apply their skills and knowledge on behalf of the low-income, disadvantaged and unrepresented. Minnesota Justice Foundation links committed law students with attorneys to provide quality pro bono legal services, to encourage public service, to help shape public policy, and to promote social justice. Law School Public Service Program - Create opportunities for law students to volunteer at legal services providers or with private attorneys who are providing pro bono services to legal services providers. With 74% of student volunteers reporting for the FY 2016, they have provided 22,020 hours of service to 5,061 clients. Summer Clerkship Program - 16 law students were paid a stipend to work full time for 10 weeks at a legal services provider. 12 worked at agencies in the metro area and 4 worked at agencies in greater MN.
