The MTC hosted the following state tournaments: girls' golf, football, wrestling, baseball and softball. East Region/EDC tournaments hosted by the committee include: boys' tennis, girls' golf, cross country, girls' swim/dive, wrestling, boys' swim/dive, basketball, track & field, baseball and softball. The "C" Squad girls and boys basketball tournaments were counted as two events since the boys and girls events were held at different sites with different staffing and site managers. We hosted invites and other tournaments for volleyball and hockey. The Committee hired numerous individuals to host, coordinate, and provide security at the games. Food and beverages were provided for these individuals.
