AKW GRANT PROVIDED EDUCATIONAL SERVICES FOR 360 CHILDREN DURING THE 2015-2016 SCHOOL YEAR IN A FULL YEAR CENTER BASED OPTION. OF THE 360 CHILDREN SERVED, 50 WERE CLASSIFIED AS HOMELESS AND 13 WERE IN THE FOSTER CARE SYSTEM.
