Short Form Return Part III Program Service Accomplishments-Line 28: The Midwest Basketball Group is organized and operated exclusively for the charitable or educational purpose of providing opportunities for amateur youth (under the age of 18) in Nebraska to obtain college scholarships through their participation in the sport of basketball. On May 27-29, 2016, the Midwest Basketball group hosted the Midwest Basketball Showcase tournament in Omaha, Nebraska. The MBS tournament was created to allow college recruiters the chance to evaluate amateur youth basketball players from Nebraska and other midwestern states so that the college recruiters could determine if certain players were talented enough to be offered a college scholarship. The net revenue generated by the MBS tournament is also utilized to defray expenses for 4 amateur youth basketball teams as set forth in Part I above. Approximately 40 youth from Nebraska under the age of 18 benefitted from the Midwest Basketball Group's contributions to their travel costs, registrations fees as it enabled them to travel to other regional and national tournaments outside of Nebraska to be evaluated by college recruiters.
