DURING THE YEAR, THE DIALYSIS CENTER PROVIDED ALMOST 33,000 OUTPATIENT HEMODIALYSIS TREATMENTS. MORE THAN 4,600 DIALYSIS TREATMENTS WERE PROVIDED TO HOSPITAL INPATIENTS. IN ADDITION, THE DIALYSIS CENTER PARTICIPATES IN RESEARCH PROGRAMS RELATED TO KIDNEY DISEASE AND TREATMENT.
