Our core function is providing a venue for the collection of toys for disadvantaged children. All monetary donations are used to purchase toys which are then added to those collected at the solicitation event and forwarded to other 501c3 organizations for vetting and distribution. Any expense is directly related to the event. Event expenses consist mainly of insurance, permits, rentals, boxes for toys, and any used for minor donation gifts (t-shirts, donuts, sodas). A large portion of the event expense goes to insurance and porta-potties. Grants listed here are non-cash, ALL TOYS, and are shown in schedule M. As this is our core function, all revenue listed also includes those contributions made for the purpose of the event function support but not needed for that event year which were combined with all other funds and used to purchase more toys. Remainder covered background or sustaining costs with a cash core held towards the next year's event needs.
