PRIVATE THERAPY SERVED 94 CLIENTS WITH 83 PERCENT ACHIEVING THEIR TREATMENT GOALS. SCHOOL PROGRAMS SERVED 132 CLIENTS AT ELEVEN SCHOOLS WITH 93 PERCENT ACHIEVING THEIR TREATMENT GOALS. THE SCHOOL PROGRAM DEPARTMENT EXPANDED ITS USE OF CREATIVE ARTS THERAPY BY CONTRACTING ART, DANCE, MOVEMENT, DRAMA AND MUSIC THERAPY AT ONE SCHOOL ACROSS THE YEAR. COMMUNITY PROGRAMS SERVED 818 CLIENTS AT FIFTEEN SITES WITH 87 PERCENT ACHIEVING THEIR TREATMENT GOALS. THREE NEW PARTNERSHIPS WERE ESTABLISHED DURING THE YEAR.
