IN 2015, CITY LACROSSE BEGAN OFFERING LACROSSE CLINICS IN PE CLASSES IN 6 MIDDLE SCHOOLS IN SOUTH LA AND INGLEWOOD. FROM THOSE CLINICS, A 10-WEEK AFTER-SCHOOL SPRING SEASON WAS BORN ENGAGING 81 BOYS AND GIRLS IN 6TH AND 7TH GRADE. IN THE SUMMER OF 2015, CITY LACROSSE OPERATED 2 TRAVEL TEAMS AND CONDUCTED AN OVERNIGHT CAMP IN COLLABORATION WITH THE OAKLAND LACROSSE CLUB. TODAY, CITY LACROSSE OPERATES YEAR-ROUND PROGRAMMING AND SERVES MORE THAN 250 PARTICIPANTS ACROSS 6 PROGRAM SITES IN SOUTH LA, INGLEWOOD AND COMPTON.
