C. After exercising due diligence, the Governing Board or Committee shall determine whether the organization can obtain with reasonable effort a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest.

D. If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the Governing Board or Committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the organization's best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination, it shall make its decision as to whether to enter into the transaction or arrangement.

As supervisor for the Executive Director, Board Chair leads steps needed to complete ED review evaluation. Board Chair conducts performance evaluation with the assistance of the Executive Committee (and/or the ED performance and salary review subcommittee). They also review key job responsibilities to ensure they are still accurate. ED completes a self evaluation and submits to the Board Chair. Board Chair reviews with Executive Committee (and/or the ED performance and salary review subcommittee). Board Chair prepares draft ED review evaluation based on Board Chair and and BOD feedback. Board Chair provides a copy of the completed evaluation to the ED to read and review before the scheduled discussion. Board Chair signs the evaluation. The ED provides any final comments, if desired, and signs evaluation. Executive Committee (and/or the ED performance and salary review subcommittee) recommend whether salary increase is appropriate, along with recommended salary increase amount. Full Board approves/disapproves salary recommendation.
