THE EVENT PROVIDED THE OPPORTUNITY FOR APPROXIMATELY 16,300 TEN-MILE PARTICIPANTS AND 2,000 FIVE-KILOMETER PARTICIPANTS WHO ARE MORE COMFORTABLE RUNNING A SHORTER DISTANCE TO TAKE PART IN ACTIVITIES THAT PROMOTED THEIR HEALTH AND FITNESS, PROVIDED AN ENJOYABLE EXPERIENCE AND HELPED FIGHT CONCERNS OVER THE GROWING OBESITY CRISIS IN THE UNITED STATES. THE EVENT OFFERED EDUCATIONAL OPPORTUNITIES FOR PARTICIPANTS AT A SERIES OF CLINICS COVERING TRAINING, INJURY PREVENTION, AND NUTRITION, AT THE HEALTH AND FITNESS EXPOSITION.
