Board have expertise in the field of Pharmacy and most are either practicing or retired Pharmacists. Because the Foundation's charitable programs are focused on the pharmacy community, it is reasonable that the Board of the Foundation come from and are elected by Pharmacists. In addition, as pharmacists, the Board has the specialized knowledge needed to administer the programs sponsored by the Foundation. The Board members come from a geographically dispersed area around the State of Georgia and thus represent a broad cross-section of the views and interests of those served by the Foundation.
