WISH GRANTING WE GRANT ONE PERSONAL, HEARTFELT WISH FOR EVERY CHILD IN OUR TERRITORY BETWEEN THE AGES OF 2 1/2 AND 18 YEARS OLD WHO HAS A LIFE-THREATENING MEDICAL CONDITION, AS DETERMINED BY THE CHILD'S OWN PHYSICIAN. IN 2015 WE GRANTED 268 WISHES FOR CHILDREN WITHIN OUR TERRITORY - ARKANSAS, NORTH MISSISSIPPI AND WEST TENNESSEE. THESE WISHES IMPACTED OVER 1,000 PEOPLE DIRECTLY IN OUR PRIMARY PROGRAM-THE WISH CHILD, THEIR FAMILY, THE WISH GRANTING VOLUNTEERS, AND THE WISH SPONSORS WHO PARTICIPATED IN THE UNVEILING OF THE WISH. TOTAL WISHES GRANTED FOR THE FISCAL YEAR WERE \$2,794,112. OF THIS AMOUNT, \$495,250 WAS CONTRIBUTED BY VARIOUS VENDORS WHO PROVIDED IN-KIND CONTRIBUTIONS. ADDITIONALLY, THE CHAPTER PROVIDED SUPPORT TO OTHER CHAPTERS THROUGH THE NATIONAL WISH FULFILLMENT FUND IN AN AMOUNT OF \$25,000.
