

THE PEBBLE PROJECT PROVIDED EFFECTIVE ABUSE PREVENTION TRAINING TO 6,091 CHILDREN DURING THE 2015-2016 SCHOOL YEAR ON 41 ELEMENTARY SCHOOL CAMPUSES. THE PEBBLE PROJECT PREVENTS CHILD ABUSE AND NEGLECT BY EMPOWERING CHILDREN TO CONTRIBUTE TO THEIR OWN SAFETY THROUGH RECOGNIZING ABUSIVE OR DANGEROUS SITUATIONS, RESISTING BULLIES, AND TELLING A TRUSTED ADULT IF THEY HAVE BEEN HARMED. THE PEBBLE PROJECT TEACHES STUDENTS TO BECOME THEIR OWN ADVOCATES.

THE SMARTKIDS PROGRAM BEGAN 15 YEARS AGO IN PARTNERSHIP WITH THE CITY OF AUSTIN HOUSING AUTHORITY AND IT HAS HAD CONSISTENT POSITIVE OUTCOMES FOR THE STUDENTS ENROLLED IN THE PROGRAM. SMARTKIDS PROVIDED A WIDE RANGE OF SUPPORTS FOR 364 CHILDREN LIVING IN PUBLIC HOUSING LAST YEAR, INCLUDING ACADEMIC, EMOTIONAL, BASIC NEEDS, AND FAMILY SUPPORT. SMARTKIDS COORDINATORS WORK WITH STUDENTS BOTH ON THEIR SCHOOL CAMPUS AND AFTER SCHOOL AT FOUR PUBLIC HOUSING SITES.

THE NATIONALLY RECOGNIZED XY-ZONE IS A LEADERSHIP DEVELOPMENT AND PEER SUPPORT PROGRAM FOR HIGH SCHOOL MALES. THE PROGRAM CURRICULUM IS FOCUSED ON THE FIVE R's - RESPECT, RESPONSIBILITY, RELATIONSHIPS, ROLE MODELING, AND REACHING OUT. STUDENTS PARTICIPATE IN GROUP ACTIVITIES AND SERVICE LEARNING PROJECTS THAT BENEFIT THE COMMUNITY. IN 2015-2016, 427 STUDENTS PARTICIPATED IN THE PROGRAM AND 90% SHOWED IMPROVEMENT IN GRADES, ATTENDANCE, AND/OR BEHAVIOR.
