Inclusive of contributions made to the program in fiscal year 2016, this program generated total revenue of \$818,575 and expenses of \$590,575 for a program net of \$228,000.

The Colorado Leadership Alliance develops the next generation of Colorado's leaders through a consortium of leadership education programs at undergraduate institutions across Colorado. CLA coordinates a rich array of programmatic and resource development support for its programs on more than thirteen campuses (CSU-Ft. Collins, CSU-Pueblo, the US Air Force Academy, CU-Boulder, CU-Colorado Springs, CU-Denver, University of Denver, University of Northern Colorado, Regis University, Metropolitan State University of Denver, Otero Junior College, Front Range Community College and Johnson & Wales University). In addition to these activities, the Foundation awarded \$126,000 in scholarships to Metropolitan State University of Denver, the University of Northern Colorado, and the University of Colorado through the FirstBank Colorado Scholars Program. Inclusive of contributions made to the program in fiscal year 2016, this program generated total revenues of \$23,275 and expenses of \$153,792 for a program net of (\$130,517).
