 Strengthening Families Program is a drug prevention program implemented in Navarro and McLennan counties for students in 1st through 12th grades and their families where the risk of substance use and abuse are increased due to a lack of stress management and family structure In FY 2016, the program had a completion rate of 80%, but all who completed the program were successful, resulting in an overall success rate of 80%

 Too Good for Drugs is a school-based drug prevention education program designed for all students in grades K-12 Students in school districts in Navarro, Kaufman, Freestone, Limestone, Hill, McLennan, Bosque, Milam, Hamilton, and Falls counties participate in the program in classroom sized groups Multiple sessions are provided to teach and reinforce social skill development that empowers students to make healthy decisions for themselves In FY 2016, the program had a 95% completion rate with 100% of those completing the program successfully, resulting in an overall success rate of 95%

 The Project Toward No Drug Abuse program is offered at Navarro County and CISD Alternative Education Programs, as well as in McLennan, Bosque, and Falls counties, and is implemented in small group sessions Although this program is a drug prevention program, the participants have already experienced some problems that are more serious than other students so a more intense program is offered A curriculum with multiple sessions is provided along with intervention counseling, case management, problem I D and referral, and follow-ups on the referrals In FY 2016, the program had a 97% completion rate with 100% of those completing the program doing so successfully for an overall success rate of 97%
