


**Vineyard Early Childhood Center achieved the following: (1) Achieved a two level jump from a "Two Star" quality rating to a "Four Star" quality rating through Ohio's "Step Up to Quality" program, which recognizes excellence in early childhood education program. This required a significant lift in teacher training, individualized child tracking, and a greater investment in curriculum development; (2) This quality shift also paved the way for additional funds allocated to replacing all child-friendly furniture within the classrooms and building a sun-shield over our outdoor play area; (3) Installed a new Director and Assistant Director overseeing all day-to-day operations in VECC; (4) Increased to 65%, a 5% increase, the percentage of enrolled children from low- to moderate-income families (measured by eligibility for Title XX), reflecting continued diversity of families served; and (5) Maintained six all-day classrooms, for ages six weeks to five years (plus half-day, pre-school during academic year) and, against licensed capacity of 104 children per day, had average daily attendance of 84.5 children.**

**The Organization's after-school and summer programming for school-age children is organized in grades K-5, known as "Vineyard After School" and "Vineyard Summer Program," respectively, and grades 6-12 are broken out into "Launch MS" and "Launch HS". These programs achieved the following: (1) New partnerships with Future Ready brought 2 important new tools to the Organization – first, Learning Circles allows online third party access to students grades for focused tutoring and assistance, while SEL uses the DESSA tool to rate children's social/emotional development. These tools have been integrated into our K-12 programming. (2) The Vineyard Summer Program's enrollment remained at 160 children K-5th, approximately 52% received subsidized services, and maintained its successful partnerships by bringing in 6 Americorps/VISTA Summer Associates and 5 Godman Guild summer interns; (3) LAUNCH: Life Readiness for High School Students completed its 4th academic year with an average daily attendance 12.5, while continuing to serve 29 overall students, and developing partnerships with Northland HS in Columbus; (4) Vineyard After School and Launch MS (K-8th) had high enrollment at 83 children, and saw its daily average attendance increase slightly to 53 (an 8% increase) children per day – leading to additional attention to parent and school engagement. In addition, the Organization launched the Community Connector Mentoring Program (see description on Schedule O in response to Part III, Line 2).**

**The Organization's Social Outreach Programs achieved the following: (1) Continued with a full-time immigration attorney (pursuant to authorization granted in 2011 by the U.S. Department of Justice, Executive Office for Immigration Review, Board of Immigration Appeals), hosted community awareness events and trainings, and launched a volunteer driven weekend clinic for immigration questions and services; (2) average number of programs/classes offered per month decreased from 47 to 43 as we continue to see a large drop in summer offerings due to summer youth program; (3) average attendance at classes and programs remained strong at 3,950 (excluding the summer); and (4) volunteers contributed nearly 5,000 hours last year in programming.**

**Form 990, Part III, Line 2: A large new program was established under the Organization's school-age youth education program by a grant through the Ohio Dept. of Education (ODE) called Community Connector Mentoring Program. This joint partnership between the Organization, Columbus City School (CCS), and Miles McClellan Construction received \$100,000 to launch One Child One Community (OCOC), with a goal of 100 mentors for 100 students across 5 elementary schools. The first year saw the Organization establish 87 mentor/mentee relationships. OCOC was honored as an outstanding program the first year, with plans to expand in the 2016-2017 school year.**

**Form 990, Part III, Line 4d: The Organization's Sports & Exercise Programs (Expenses \$192,499) (Revenue \$116,485) saw a slight decrease in participation, from 3,459 avg. per month to 3,028 (12.5% decline). The average number of volunteers remained steady at 45 per month, contributing to nearly 1,400 hours of volunteer service. Additionally, in the winter of 2016, Vineyard Athletics entered a formal partnership with NOVA Village for AAU programming and launched 13 AAU basketball teams. The High School teams generated 13 college scholarships offers for its participants.**

**Form 990, Part III, Line 4d: The Organization's Free Health Clinics (Expenses \$107,740) (Revenue \$25,996) achieved the following:**

**(1) continued a partnership with Lower Lights Christian Health Clinic (FQHC) to utilize facilities at the Organization's two free clinic locations (Weinland Park community and VCC building); (2) The total patients served was 1,184 (4% increase) despite the continued decline in free clinic patient visits across the State of Ohio; and (3) Organized over 140 volunteers with total of 1,394 professional hours served and 1,785 clinic support hours served for a total of 3,180 volunteer hours provided, and the conservative overall value of services rendered exceeds \$255,000.**
