The Joint Commissioned Accredited Clinical department provided 6,214 adolescents and adults counseling, assessment, education, and peer-led treatment. Clinical also provided screening and phone counseling to over 11,408 clients. Behavioral Health/PTSD counseling services were provided to 185 veterans and their families through the Veteran's programs. The results of the Veterans program was evaluated independently by UNTHSC. Housing and case management services were provided to 49 formerly homeless clients while networking with other organizations to provide a holistic approach to overcoming obstacles facing homeless clients.

The Education and Prevention department provided 48,549 children and youth Health and Wellness education/ services within Tarrant and Johnson counties in 20 plus school districts, with 4,847 youth receiving multi-week evidence based curriculum based programs that reduced at risk behaviors and improved academic/classroom performance. Of the total children and youth served, 79% were to youth under the age of 17. The remaining 21% of services were delivered to adults, 18 and older, in various settings. Three, 1-week camps were held for youth living in shelters and youth of the families served through RRC.
