7024U Youth Outreach is working to give Artesia's youth the necessary tools to become productive members of the community and society through prevention, intervention and treatment services. The Center was developed to engage, empower and educate youth while providing them with advocates and educators with relationship building, training and skills that are youth focused. Participants are picked up from school and taken to the Center each day where they engage in various activities, receive tutoring, and enjoy a group meal before being taken home in the evening.

7024U joined with ADCC to apply for and receive their own 501(c)(3) determination this year under the name Changing Lives Coalition. All remaining cash and assets were donated to this new public charity in March 2016.

4b (Code:) (Expenses \$ 101,764 including grants of \$ 63,860) (Revenue \$ 0)

Artesia Drug & Crime Coalition was formed to combat drug abuse and crime in the Artesia area through public awareness. This program benefits all citizens in the area. Staff attends Community Based monthly meetings with Eddy County D.W.I., Chamber of Commerce, Carlsbad Coalition, Human Rights, 7024U Outreach Center, My Neighborhood & Guardians of the Children. ADCC works weekly with Student Action groups at Zia Intermediate School, The Artesia Recreational Center and Sticker Shock Kids (high school & MIP's). The primary focus for these groups is avoidance of Underage Drinking and Bullying. Coalition community partnership projects included Eddy County Fair, Artesia Homecoming Parade, Red Ribbon Week, National Night Out, APD Safety Fair & APD Drug Take Back Day. ADCC provides information to the public on drugs, bullying, gangs and other related crimes. They work closely with families that have loved ones that are caught up in drugs to find rehab centers and attend court hearings with them to help them understand the process.

ADCC joined with 7024U to apply for and receive their own 501(c)(3) determination this year under the name Changing Lives Coalition. All remaining cash and assets were donated to this new public charity in March 2016.

4c (Code:) (Expenses \$ 56,565 including grants of \$ 5,135) (Revenue \$ 4,480)

Friends of the Artesia Public Library. Undertook three improvement projects within the new Artesia Public Library. A bronze bench featuring the Founding Documents of the U.S.A was commissioned, an artist was contracted to design stained glass for the door into the Southwest Collection Room that complimented the Peter Hurd Mural in the main library, and acoustic panels were added between the main library and the teen section. This organization also raised funds for and purchased frames to accommodate children's stories to be placed along a walking path in Artesia. FOAPL raised approximately \$5,300 for the community Summer Reading Program at the Library. This group also provides promotional items (postcards, calendars, mugs, prints) for the Peter Hurd Mural featured in the Artesia Public Library.
