IICC GENERALAt the overall organizational level, IICC continued to build on the strategic planning process begun in the fiscal 2013 During the 2015 2016 fiscal year, two key goals were reached IICC/WorldView separated into two different organizations, each with independent legal status One of the two organizations continued with the name and by-laws of the Institute for International Chstian Communication dba WorldView The purpose of this organization is to provide training for people involved in cross cultural ministry An independent organization was formed by the name Sanctuary Inn, which has registered as a not-for-profit ministry to provide housing and Chnstian community for international Christian workers who are in the Portland, Oregon area As part of this separation of program elements, the WorldView Center building located at 6012 SE Yamhill St, Portland, OR was sold in June, 2016 Proceeds of the sale have stayed with the IICC organization, which in the future may consider using some portion of the proceeds to provide grants to Sanctuary Inn and/or other intercultural ministries TRAINING PROGRAMDunng the fiscal year 2015 2016, WorldView/IICC provided training for people involved in intercultural ministry Three levels of training are now provided training aimed at adults who need to learn a new language, training for adults who will soon live and work in a new culture, and training for children who are moving with their parents into another culture In the past fiscal year, IICC has provided these levels of training for approximately 140 intercultural workers serving with ministry partner agencies based out of the United States (Colorado, Missouri, and South Carolina), Argentina, Panama, Cuba, Egypt, and Uganda During the 2015-16 fiscal year IICC staff also taught as part of Western Seminary courses, and launched a non-credit certificate program in intercultural ministry in conjunction with Western Seminary
